Particulars of organization, functions and duties {Section 4(1)(b)(i)}

1. Aims and objectives of the organization

The main objective of the Department of Archaeology (DoA) is survey, listing, documentation, protection, conservation, preservation and beautification of ancient monuments of local importance worth protecting and develop them as tourist spots in Delhi under the provisions of "The Delhi Ancient and Historical Monuments and Archaeological Sites and Remains Act 2004", (DAHMSAR Act 2004) other than those of national importance protected and maintained by the Archaeological Survey of India, Government of India.

2. Mission / Vision

Delhi possesses number of ancient monuments spreading over millennia of history in the entire city. While the national monuments are governed under the provisions of "The Ancient Monuments and Archaeological Sites and Remains Act, 1958" and "The Ancient Monuments and Archaeological Sites and Remains (Amendment and Validation) Act, 2010", other ancient monuments of local importance which are worth protecting are governed under the provisions of the "Delhi Ancient and Historical Monuments and Archaeological Sites and Remains Act - 2004". All our efforts are made to ensure that approach to conservation is as per prevailing archaeological norms with due emphasis on up gradation of skills and involvement of professionals and maximum use of traditional techniques in conservation. After completing the conservation work, as per the requirement, Illumination and development of garden/landscaping work is also taken up to develop them as tourist spots. The Govt. of Delhi is making concrete efforts for preservation and conservation of these monuments in a phased manner.

The Department do survey, listing, documentation and protection of ancient monuments of local importance in the city under the provisions of aforesaid Act. The department has issued final notification declaring 19 monuments as Protected Monuments. Apart from these, 35 monuments have been preliminary notified for protection and 72 monuments has been conserved by DoA, GNCTD. Further, under "Adopt a Heritage: Apni Dharohar, Apni Pehchaan" project which is a collaborative effort by the Ministry of Tourism, Ministry of Culture, Archaeological Survey of India and State/ UTs Government for developing tourism amenities at heritage/ natural/ tourist sites spread across India for making them tourist friendly, in a planned and phased manner. The project aims to encourage companies from public sector, private sector, corporate citizens, NGOs, individuals and other stakeholders to become 'Monument Mitras' and take up the responsibility of developing and upgrading the basic and advanced tourist amenities at these sites as per their interest and viability in terms of a sustainable investment model under CSR. They would also look after the Operation & Maintenance of the same.

3. <u>Brief history and background for its establishment</u>

According to article 246 of the Indian Constitution read item 40 of Schedule VII, Archaeology is concurrent subject. The monuments of national importance are declared as centrally protected monuments under the provisions of "The Ancient Monuments and Archaeological Sites and Remains Act, 1958" of the Archaeological Survey of India, Government of India and also maintained by it whereas those of local importance found worth protecting are looked after by the respective State Governments under their own Acts through their respective State Departments of Archaeology. Hence, it became obligatory for each State Government to establish Department of Archaeology for protection and maintenance of ancient monuments of local importance worth protecting in their respective States. As such, a separate Department of Archaeology has been established in Delhi Administration in the year 1978.

- Don't underestimate the importance of any cultural heritage.
