Nine Thousand One Hundred Ninety One Only) in the form of Demand Drast/ Pay Order/ FDR in favour of DDO, Department of Archaeology, Government of NCT of Delhi, with the submission of Tender.

RMS & CONDITIONS:-

- 151: The work should be done strictly following the archaeological/Heritage conservation principles and in accordance with the specifications given in the schedule of Quantities.
- 152. The Contractor/Agency should have experience of similar works executed by them during the last Three years following Three similar completed works each of value not less than 40% of Estimated Cost of the Tender or Two similar completed works each of value not less than 60% of Estimated Cost of the Tender or One similar completed work of value not less than 80% of Estimated Cost of the Tender.
- 153. If the percentages quoted by two or more Contractors/Agencies are found same, then priority would be given to the Contractor/Agency with the higher Turnover done during last Three years.
- 154. The Percentage Rate in the Tender should be quoted in words and figures. No over writing / cutting will be accepted.
- 155. The quoted rate must be valid for one year from the date of award of the work order; nothing extra shall be paid by the Department.
- 156. Tender received after due date and time or delayed due to postal service after closing time will be summarily rejected and the department will not be responsible for this.
- 157. Secretary (ACL) reserves the right to reject any or all the tenders at any stage without assigning any reason.
- 158. The work must be completed within the time frame of 60 days from the date of award of work failing which a penalty equal to 0.05% of the Quoted cost per day subject to a maximum 5% of the Quoted cost will be imposed shall be recovered from payments due/performance security. However, for delay due to reasons beyond the control of Agency, suitable extension of time will be given by Department on submission of the same by the Agency.
- 159. The item rates are inclusive of GST, Water charges, Labour Cess and Contractors Profit.
- 160. Water is to be arranged by agency. No T & P shall be provided by the Department.
- 161. It is advisable that Contractor should visit the site positively before submitting Tender so as to be acquainted with the nature/condition of the work to be executed and how the materials will have to be stored, stacked at site or else. No material whatsoever will be supplied by the Department. The agency will also be responsible for the safety and security of the material and T & P.
- 162. Debarred/blacklisted agencies shall not be permitted to submit Tender.
- 163. Being work of ancient nature, at some instance it may require modifications or alterations in certain items of works for which Contractor will have to ensure the execution to the satisfaction of the department within the sanctioned rates until Department finds it necessary to be included for payment at different rates.
- 164. In case poor quality of work is being done, the same will be treated as negligence on the part of the contractor and hence will have to make good the same at his/her own cost to the satisfaction of the Department.
- 165. The material bought to site by the Contractor /Firm should be strictly as per specifications given in the Items of Schedule of Quantities. In absence of which, Contractor will have to exchange it with good quality material at his own risk and cost.
- 166. Originality in designs on the structure should be maintained strictly.
- 167. The Contractor shall take all precautions to avoid all accidents by exhibiting necessary caution boards day and night as safety measures. He shall be responsible for all damages and accident caused due to negligence on his part.
- 168. The work may be having typical shapes, curves, etc. Special care will be required to maintain line, level and finish. No claim by the contractor whatsoever on shape and nature of the work shall be entertained subsequently.
- 169. In case of any mishaps/accidents occurred during the discharge of duties by the labourers, the compensation liability will solely rest with the Contractor and no compensation will be paid by the Department.
- 170. In case of Disruption in work, CPWD guidelines would be followed.

- 171. All disagreements, disputes, differences that may arise between the Department and the Contractor, and, which cannot be resolved through mutual negotiations, shall be referred to an Arbitrator appointed in accordance with the provisions of relevant Indian Law as the case may be. The venue of the proceedings and arbitration shall be Delhi.
- 172. After award of work, within 7 days the Bidder should submit 5% of the Tendered amount as Performance Security (P.S) valid upto 2 months from the date of completion of work in the form of Demand Draft/ Pay Order/ FDR in favour of DDO, Department of Archaeology, GNCTD payable at Delhi which will be returned only after successful completion of work.
- 173. 10 % from every bill will be deducted as Security Deposit (S.D) which will be released after the maintenance period of six (6) months is over from the recorded completion date of work, if no defects are noticed in work during that period. If any defect is found, the S.D will be released only after such defects are rectified by Contractor/Agency on their cost to the satisfaction of the Department.
- 174. Payment of ESIC/EPF will be reimbursed as per the actual paid by the Contractor in the welfare of labour & original documents should be submitted to Department along with the Tax invoice.
- 175. The Firm must submit an undertaking on Rs. 100/- e-stamp paper with effect that the Terms & Conditions mentioned above have been completely understood by them and they are agreed.
